Use of personal data collected

Comment: When you use our website, we use cookies to enhance your user experience, to personalise your navigation.

If you have an account and log in to this site, a temporary cookie will be created to determine whether your browser accepts cookies. It does not contain any personal data and will be deleted automatically when you close your browser.

When you log in, we will set a number of cookies to store your login information and screen preferences. The lifetime of a login cookie is two days, the lifetime of a screen option cookie is one year. If you check "Remember me", your login cookie will be retained for a fortnight. If you log out of your account, the login cookie will be deleted.

Some cookies are exempt from consent: these are cookies and trackers that are strictly necessary for the provision of a service specifically requested by the user. These include: the session ID cookie for the duration of a session as mentioned above, audience measurement solutions and persistent interface personalisation cookies. However, other cookies for audience measurement or operations relating to advertising & social networks require a prior request for consent.

Statistics and audience measurement

The <u>www.simeoxconsult.com</u> website uses **Google Analytics** and **Google Tag Manager** to collect data from cookies. These cookies and tracking tools allow us to analyse behaviour and track interactions with the content we offer in order to continuously improve the quality of the content and your user experience. Simply put, we receive this information in aggregate form to help us understand how our site is used, the effectiveness of our marketing campaigns, or to help us improve and personalise our site.

Measuring the audience of the website pages, in order to allow an evaluation of the content published and the ergonomics of the website, without allowing the identification of individuals. The data collected will not be cross-referenced with other processing.

The IP address that the cookies are likely to capture is automatically anonymised before integration into Google Analytics to avoid any other use of this personal data or any cross-check with other personal information;

Finally, the anonymised cookie information will be kept for a period of 13 months.

Advertising and social network operations

PhysioAssist publishes sponsored ads on Facebook and measures the effectiveness of its **Google Ads** campaigns. The **Facebook Pixel** cookie tracks conversions from our Facebook ads and creates retargeting audiences. These two cookies allow us to measure the effectiveness of our

marketing activities.

Chatbot " Intercom " / messaging

We use a chatbot messaging system - provided by the company "Intercom" - on our site in order to be able to answer your live requests (support, advice...). Our Intercom messaging system is integrated via **Google Tag Manager**, we collect your connection information in order to adapt to the language used by your browser. This information does not make you identifiable.

We use third-party analytics services to better understand your use of our services. In particular, we provide a limited amount of your information (such as registration date and certain personal information such as your email address) to Intercom, Inc. ("Intercom") and use Intercom to collect data for analytical purposes when you visit our website or use our product.

As a data processor acting on our behalf, Intercom analyzes your use of our website and/or product and tracks our relationship through cookies and similar technologies to improve our service to you. We may also use Intercom as a means of communication, either through email or through messages in our products. The cookies used by the Intercom messaging service are said to be "first-party" and assigned to the domain of our site. We take the confidentiality and protection of your data very seriously and these cookies cannot be read on other sites or by other companies using the same Intercom service.

Below are the cookies used by the Intercom chatbot, their purpose, duration and description:

Cookie Name	Purpose	Default Duration	Description
intercom- id-[app_id]	Unique anonymous identifier	9 months	Anonymous visitor identifier cookie. As people visit your site they get this cookie.
intercom- session- [app_id]	Keeping track of sessions	1 week	Identifier for each unique browser session. This session is refreshed on each successful logged-in ping, extending it to 1 week from that moment. The user can access their conversations and have data communicated on logged out pages for 1 week, as long as the session isn't intentionally terminated with `Intercom('shutdown')`;, wich usually happens on logout

Your account access and delivery information will not be used for commercial purposes without your consent. Only a voluntary subscription to our newsletter allows us to send you promotional or informational emails other than those resulting from the purchase of a good or a quote request.

Embedded content from other sites
